HB 1435 (Springer), SB 5792 (Saloman) – Cultural Access programs, same requirements for all counties

- Eliminates requirements for cultural access programs related to public school access and financial allocation that apply only to counties with a population of more than 1.5 million.
 - Applies requirements related to public school access and financial allocation for counties with a population of less than 1.5 million to all counties regardless of size.

HB 2007 (Maycumber) - Concerning contracting for local art funded through the capital budget art allocation

Jan 13 By resolution, reintroduced and retained in present status (House Committee on Capital Budget)

- Requires the Washington State Arts Commission, when selecting artists for capital construction projects, to give preference to artists within 100 miles of the project site.

HB 2120 (Vick) - Creating a work group to study and make recommendations on a statue to replace the Vladimir Lenin statue

Jan 13 By resolution, reintroduced and retained in present status (House State Government & Tribal Relations)

- The legislature intends to request a replacement of the statue of Vladimir Lenin in the Fremont neighborhood of Seattle.
- A work group is created to study and make recommendations on an appropriate historical figure to replace the statue of Lenin and to represent the state of Washington on the street corner in Fremont where the statue of Lenin is currently located.

HB 2134 (Young) - Establishing a task force to commemorate George Washington Bush through art

Jan 13 By resolution, reintroduced and retained in present status (House Appropriations)

- Commemorating Washington state founding father 2 George Washington Bush through art in the internal southern portico of the legislative building.
- George Washington Bush was one of the state's earliest pioneers and foremost founding fathers, an American hero of Irish and African descent who pioneered settlement of the Pacific Northwest.

HB 2155 (Morgan) – Designating *Suciasaurus rex* as the state dinosaur

Jan 13 By resolution, reintroduced and retained in present status

Jan 20 - Substitute Bill was referred to Rules for review

Feb 4 - Placed on second reading by Rules Committee

- In April 2012 an 80-million-year-old theropod fossil was found in the San Juan by a group of researchers from the Burke Museum of Natural History and Culture in Seattle. It was the first dinosaur fossil discovered in Washington state. Dinosaur fossils are rare in the Pacific Northwest because active tectonic plate boundaries nearby have resulted in significant geological turmoil.

- Parks and Recreation, commission must establish a scenic bikeways program.
- Commission to give priority to the designation and implementation of scenic bikeways that will add variety to the geographic location, topography, route length and difficulty, and cultural, historic, scenic, and recreational value of the statewide scenic bikeway system or that will complete existing bicycling networks.
- Consult with Department of Transportation.
- The Commission may have sponsorship agreements with nonprofit entities or private businesses or entities for sponsorship signs.

HB 2757 (Corry) – Concerning official state designations.

- Ellensburg blue agate is gem unique to Washington. Formed by mineral-dense fluid in small cavities of Teanaway basalts.
- Designate as official gem of Washington. Semiprecious gem.
- Columbian mammoth is official *vertebrate* fossil of Washington.
- Petrified wood is designated as official vegetative fossil of Washington.

HB 2837 (Boehnke) – Expanding powers granted to state historical societies

HB 2850 (Lekanoff) Protecting archaeological and cultural sites by state and local governments and all recipients of state funding.

Jan 27 First reading, referred to State Government & Tribal Relations

Feb 4 Public hearing in the House Committee on State Government & Tribal Relations

- Protect rich and diverse cultural heritage as represented by numerous archaeological and cultural sites
- Consult with tribes before engaging in any groundbreaking activity that may impact such archaeological and cultural sites
- Project must be reviewed by the department and interested federally recognized tribes, Governor's office of Indian Affairs and consult with all on survey and strategies for protection.

HB 2868 (Blake) Extensions of the special valuation of historic property for certain properties

- County Assessor - A property is eligible for two seven-year extensions of the special valuation if located in a city listed as distressed. Extensions must be applied for by the owner.
- All extensions must be reviewed by the local review board and may be approved or denied at the local review board's discretion.

HB 2899 (Hudgins) – Establishing the Washington state civil rights trail program

HB 2931 (Tharinger) – Providing a sales and use tax exemption for labor and services rendered related to and tangible personal property incorporated in a qualified community multipurpose arts and events facility

- Tax preference performance statement for subsequent evaluation of the tax preference. Not intended to create a private right of action by any party
- One intended to provide tax relief for certain businesses or individuals
- Qualified facility means a community multipurpose arts and events facility being built in a city with a population of less than 25,000 in a county with a population of less than 80,000 that contains a national park and national wildlife refuge
- Foster rural economic development by providing tax relief to large capital projects by nonprofit entities.

SB 5237 (Carlyle) - Creating a work group to replace certain Marcus Whitman statues

Jan 13 By resolution, reintroduced and retained in present status (Senate Committee on State Government, Tribal Relations & Elections)

- Establishing a work group to study and make recommendations on an appropriate historical figure to represent Washington state in the state capitol and the national statutory hall in the United States capitol.

SB 5712 (Hobbs) - Creating a work group to study and make recommendations on a monument to honor residents who died in the global war on terror

Jan 13 By resolution, reintroduced and retained in present status (Senate Committee on State Government, Tribal Relations & Elections)

- Creates a legislative work group to study and make recommendations on a monument on the capitol campus to honor service members who died in the global war on terror.

SB 5869 (Becker) - Concerning the exhibition of art on the capitol campus

Jan 13 By resolution, reintroduced and retained in present status (House State Government, Tribal Relations & Elections)

- In coordination with the state historical societies, the state archives, and others, the state arts commission must establish a program to furnish art, artworks, artifacts, photographs, and exhibits from the collections housed in the Washington state history research center and any donations to the state for display in the legislative buildings of the capitol campus.

SB 5953 (Ericksen) - Designating the peace arch as the state peace monument

Jan 13 By resolution, reintroduced and retained in present status (Senate State Government, Tribal Relations & Elections)

- The sixty-seven foot concrete peace arch was constructed in 1921 to honor the centennial of the treaties resulting 10 from the War of 1812. The peace arch was the first arch in the United States to be dedicated to peace and is still one of very few in the world. Located on the border in Blaine, Washington, the peace arch monument serves as an important symbol of the state of Washington.

SB 6093 (Schoesler) – Concerning free public access to state parks and lands

- Endemic to the Pacific Northwest and abundant on Washington's sandy coastal beaches, the Pacific razor clam, *Siliqua patula*, is an important part of the cultural identity of the state.
 - The Pacific razor clam is an icon of the state worthy of the title of official clam of the state of Washington

SB 6260 (McCoy) - Tribal traditional and cultural interests in water resources

Jan 14 First reading, referred to Senate Committee on Agriculture, Water, Natural Resources & Parks

Jan 21, 1:30 p.m. - Public hearing held in the Senate Committee on Agriculture, Water, Natural Resources & Parks

- Allows any Washington tribe to file a description of its historical and current uses of a surface or ground water body that support the cultural, spiritual, ceremonial, and traditional rights or lifeways of the tribe, with the Department of Ecology (Ecology).
 - Requires Ecology to recognize the tribe's traditional and cultural interests in the water body when the filing is supported by certain documentation.
 - Requires Ecology to consider recognized tribal traditional and cultural interests when reviewing various water right applications.
 - Restricts Ecology from categorically exempting, from the requirements of the State Environmental Policy Act, water right applications for a new water right in which there is a recognized tribal historical and cultural interest.
