June 19 has been celebrated as "Juneteenth" or Emancipation Day to commemorate the abolishment of slavery and recognize the contributions of Black/African Americans to society. In 2007 the Legislature designated Juneteenth a legislatively recognized day as a day of remembrance for when slaves learned of their freedom. Forty-six states recognize Juneteenth as either a holiday or day of observance. The bill would designated June 19 as Juneteenth Day, a state holiday.

HB 1069 (Pollet) - Concerning local government fiscal flexibility

Provides local governments increased flexibility in the use of existing revenues in order to enable local governments to continue to provide essential services and to facilitate economic recovery through December 31, 2023. An amendment was adopted that removed provisions allowing lodging tax revenue to be used for housing and rental assistance through December 31, 2023.

HB 1101 (Walsh) - Creating a grant program for converting unused public buildings to housing for homeless persons

The public building conversion grant program is created in the Community, Trade & Economic Development Department. The purpose of this program is to encourage counties to convert unused, publicly owned buildings into housing for homeless persons.

HB 1279 (Rule) - Modifying the Washington main street program tax incentive to respond to the economic impacts of the COVID-19 pandemic

 January 19 - First Reading Referred to House Finance

Changes the Main Street tax incentive program, increasing the amount of the overall cap on the program from \$2.5M to \$4M, and increasing the value of the credit from 75% to 90% for business owners participating in the program.

<u>SB 5059</u> (McCune) - Protecting state and federal monuments, memorials, and statues from damage intentionally inflicted during the course of unpeaceful demonstrations or riots

Makes defacing a ((state)) public monument a Class C felony (previously a misdemeanor).

SB 5161 (Wellman) - Teaching Washington's tribal history, culture, and government

 Referred to Early Learning & K-12 Education
- January 18 Public Hearing in Senate Early Learning & K-12 Education

Beginning July 24, 2015, when a school district board of directors reviews or adopts its social studies curriculum, it shall incorporate curricula about the history, culture, and government of the nearest federally recognized Indian tribe or tribes, so that students learn about the unique heritage and experience of their closest neighbors.

SB 5238 (Hasegawa) - Creating a Washington state creative economy work group

 January 15 - First Reading Referred to Business, Financial Services & Trade

Within two years, develop a strategic plan to improve the Washington state creative economy that can be rolled out in incremental phases to reach identified economic, social justice, and business development goals.
