About this Grant

ArtsWA is pleased to offer Arts in Education staffing support in service of PreK-12 students as they navigate the ongoing impact of the COVID-19 pandemic. Disruptions in schooling, including school closures and cancelled programming, continue to impact students' school engagement and academic progress. This is especially the case for communities that experience limited access to arts learning materials, internet, and accessible arts and cultural programs. These A4A Recovery Grants are intended to stabilize community-based learning options, stimulate hiring and rehiring, bring teaching artists into the classroom, and relaunch arts and cultural programs.

Use of Funds

Grant recipients may use A4A Recovery Grant funds for staffing expenses that directly support arts and cultural learning opportunities for PreK-12 students. Staffing expenses can include part-time, full-time, and non-permanent work for teaching artists, certified teachers, and/or program administrators working in service of PreK-12 students and families. * Staffing expenses must be incurred between July 1, 2022 through June 30, 2023. Grant recipients will be required to submit expense documentation and a final report to ArtsWA.

**Hiring certified teachers with one-year grant funding may not be a contractual option for districts and school hiring. In this case, professional service contracts with content experts in the community is encouraged.*

Funding for these A4A Recovery Grants is made possible by the Washington State Arts Commission's Coronavirus State Fiscal Recovery Funds from the State of Washington and the United States Treasury.

Funding Amounts

- Organizations may apply for \$10,000 or \$20,000 (no other requests)
- No matching funds required

Important Dates

- Application Opens: January 13, 2022
- Application Deadline: Applications are accepted until February 24, 2022, 5:00 pm
- Notification of Grant Awards: by May 2, 2022
- Funds Available: Between July 1, 2022 - June 30, 2023
- Final Report Due: July 31, 2023

Eligibility

Who Is Eligible to Apply?

- Nonprofit arts and cultural organizations with current federal tax-exempt status under Section 501(c)(3) of the Internal Revenue Code, including those affiliated with tribal organizations.
- PreK-12 public schools, school districts, Educational School Districts (ESD)
- Tribal, state, or municipal government agencies

Who Is Not Eligible to Apply?

- Individuals
- For-profit organizations
- Fiscally sponsored organizations
- Private schools
- Higher education institutions
- Political or advocacy organizations
- Organizations based outside of Washington State
- Organizations seeking to fund staffing for programs that promote religious content

Can organizations apply for multiple ArtsWA grants?

Applicants to the A4A Recovery Grant program can apply for and receive other ArtsWA grants if those funds are used to support different expenses and services from those outlined in their A4A Recovery Grant application. This includes:

- [Creative Start Grant](#) – Opens March 10, 2022
- [Arts in Education Partnership Grant](#) – Opens February 17, 2022
- [Grants to Organizations](#) – Ongoing

Not Allowable: Applicants may not apply for both the Arts in Education Partnership Grant and Creative Start Grant programs in a single fiscal year.

Application Criteria

Panelists will assign each A4A Recovery Grant application a score between 0-30 using the criteria and point system below. 30 points is the highest possible score for this grant application.

The A4A Recovery Grant is supported by Coronavirus State Fiscal Recovery Funds. Criteria must focus on COVID-19 related impacts, not project-specific criteria.

1. **Financial and Staffing Need (10 points possible)**

The applicant demonstrates significant loss of PreK-12 arts and cultural learning opportunities due to staffing furloughs and/or budget shortfalls caused by COVID-19 related impacts. This may include, but is not limited to:

- Insufficient arts education staffing to sustain programming
- Cancelled arts and cultural learning opportunities due to budgetary concerns
- Furloughed staff and related impacts

2. **PreK-12 Arts and Cultural Programming (10 points possible)**

The applicant demonstrates a clear focus on providing arts and cultural learning in service of PreK-12 students and families. Application outlines past and anticipated arts programming.

- Past programming includes a clear focus on Visual Arts, Music, Dance, Theatre, Media Arts, Literary Arts, Folk and/or Traditional Arts
- Art learning opportunities are accessible to the communities served

3. **COVID-19 Related Learning Disruptions (10 points possible)**

The applicant demonstrates one or more of the following interruptions to PreK-12 arts learning (*learning disruptions may be past, intermittent, and/or ongoing*):

- Cancelled learning opportunities due to health and safety policies and guidelines
- Insufficient internet and/or technology access
- Geographic access (ie; physical distance to arts and cultural programs is limited)

How to Apply

All A4A Recovery Grant applicants must submit a completed application form online through Submittable. ArtsWA will accept applications in Submittable starting January 13 through **February 24 at 5:00 pm**.

A4A Recovery Grant Application Requirements

- **SWV Number:** Organizations must have an [SWV \(Statewide Vendor\) number](#) to receive grant funds from the state. An SWV number is not required to apply but must be registered and up to date before funds are given. An SWV number can take up to three weeks to be assigned. If your organization has received payment from Washington State in the past it is likely you already have an SWV number. You can check on the status of your SWV number by using the [vendor number lookup](#).
- **DUNS Number:** Organizations must have a [DUNS number](#) to receive grant funds from the state. A DUNS number is not required to apply but must be registered and up to date before funds are given. A DUNS number can take up to two business days to receive. You can look up or register for a DUNS number by visiting the [Dun & Bradstreet website](#).

Additional Requirements for 501(c)(3) Organizations

A4A Recovery Grant applications from nonprofit arts and cultural organizations with current federal tax-exempt status under Section 501(c)(3) of the Internal Revenue Code must include uploaded copies of the following documents as part of their submission:

- **IRS Form 990 for 2019**
- **IRS Form 990 for 2020**
- **IRS Determination Letter**

General Grant Policies

- **Payments:** will be made after the grant recipient's staffing plans, expense documentation, and invoice forms have been submitted to and approved by ArtsWA.
- **Final Reports:** Grant recipients must submit a final report to ArtsWA by July 31, 2023.



- **Documentation:** Grant recipients must track expenses, keep clear records, and provide appropriate and timely documentation.
