

### WHAT IS BUILDING FOR THE ARTS?



- Building for the Arts awards state grants to nonprofit community-based organizations to buy, build, or renovate arts and cultural facilities
- Grants to eligible organizations up to 33 percent state match of eligible project costs
- RCW 43.63A.750

### WHICH AGENCY ADMINISTERS BFA?



 Building for the Arts is administered by the Washington State Department of Commerce

 ArtsWA supports with outreach, informational consultation

# **HOW DOES THE GRANT WORK?**

- Reimbursement-style grant for constructionrelated costs. Operating costs are ineligible
- Competitive grant application process held every two years
- Grant applications are screened by staff and then ranked by an advisory board

# WHO IS ELIGIBLE TO APPLY?




- Open to tribal entities and nonprofit arts organizations based in Washington State
- Historical museums are not eligible

# **ELIGIBILITY STANDARDS**

- be a Tribe or registered in the state
   agree to LEED certification of Washington as a nonprofit organization
- have binding control of the site thru ownership or long-term lease
- legally constituted board of directors

- exemption
- agree to pay state prevailing wages; and
- have made substantial progress in a capital fundraising campaign

### WHAT TYPES OF PROJECTS CAN BE FUNDED?



- Buy, build or renovate arts and cultural facilities
- Art and cultural centers
- Theatres, performing arts centers, etc.

History museums are NOT eligible

# BUDGET, FUNDING AND MATCH

- \$18M cap for available funds per biennium
- Required match, reimbursable
- Grant can provide up to 33% of eligible project costs

### WHAT COSTS CAN BE REIMBURSED?


#### **ELIGIBLE COSTS**

- design, architectural, and engineering
- permits/fees; archeological review
- construction labor and materials
- IT infrastructure (cables and wiring)
- construction management (external)
- initial furnishings; landscaping
- real property

#### **INELIGIBLE COSTS**

- internal administrative activities
- project management
- Fundraising or feasibility studies
- computers, office equipment, vehicles
- lease payments or rentals
- mortgage or leases
- moving of equipment
- non-capital expenses, such as a website

## HOW ARE PROJECTS SCORED?



- Ability to complete project expediently
- Organizational capacity
- Community need
- Availability of other funding sources

## **CONDITIONS FOR SUCCESS**

#### ORGANIZATIONAL FITNESS

- Can your organization make the project happen?
- Do you have capacity to manage facility long-term?
- Would you be able to move the project forward without BFA?

#### MARKET NEEDS / ASSESSMENT

- Does the community want this project?
- Data to back up demand
- Who else is doing this work in your area?

### FEASIBILITY STUDY




- How practical is your project? How likely is it to come to fruition?
- Components of a feasibility study include: preliminary analysis, organization readiness, market assessment, financial analysis, project and funding timeline

### FINANCING YOUR PROJECT


- Determine a reasonable budget
- Do you have any initial investment for this project?
- If not, how are you going to secure funding?

## HOW TO DETERMINE PROJECT TIMELINE

- Start with the end in mind
- Which phase of the project are you in?
- How can you utilize project phases to access BFA funding?



### LEED CERTIFICATION OR EXEMPTION?

- "Green" building standards
- LEED Silver
- Exemptions: land acquisition, new construction under 5000 sq. ft.; renovation costs <50% of assessed value & under 5000 sq. ft.; research facilities

### PREPARING TO APPLY FOR BFA

- Are you eligible and ready to apply?
- Can you complete the project on time & in budget?
- Can you ensure the long-term viability of your facility?

# NOTES ABOUT THE APPLICATION

- Extensive application; can apply online only
- Preliminary step to determine eligibility
- Be prepared to answer extensive questions about budget, project scope

# REVIEW CRITERIA

Project readiness

Organizational capacity

Project results

Community need

Stakeholder participation

# TIPS FOR A SMOOTH APPLICATION PROCESS

- Read grant guidelines closely
- Start doing the requirements early
- Pay attention to the questions, answer appropriately
